### RULES:

1. Entries must be cancelled at least (2) classes before the class entered or late fees apply.
2. Canadian Exhibitors must pay in U.S. Currency.
3. All **IN STATE** Horses must have a current Negative (24 months) Coggins Test to enter grounds.
4. All **OUT OF STATE** Horses must have a Current (12 months) Negative Coggins Test.
5. **FOR 2010: All Exhibitors** must have a current 2010 APHA/AJPHA/ AM membership card the day of the show in order to compete in divisions ( Youth, Amateur and Open). Plus current Novice Membership if showing in Novice Youth and Novice Amateur Classes.
6. Show Management reserves the right to cancel or combine classes as warranted according to APHA Rules.
7. All classes of 22 or more entries will be split. All 7 horses on each judges card, in each preliminary split, will return for the final go.

### AWARDS:

**Class Circuit Zone Champion** will be awarded in **Each Class.** In case of TIES, Tiebreaker Judge will be drawn from the (6) Judges.His card will count twice.

**APHA Zone Hi-Pt Trophies** will be awarded in Open, Amateur, Youth and Solid Paint Bred. APHA eligibility rules apply. Rules available at Show Office.

**APHA Gelding Plus Program:** Regular registry horse must be 4 yrs and older. Halter not included in this award. Must live in Zone 7. Rules at Show Office.

**NorthEast Connection Hi-Pt Division Zone Champion** will be awarded in the following Divisions; Open, Novice Amateur, Amateur, Solid Paint Bred/Breeding Stock, Novice Youth, Youth 13yr & Under and Youth 14-18yrs. All classes within the Division count.

**NorthEast Connection Hi-Pt Division Zone Reserve Champion** will be awarded in the following Divisions; Open, Novice Amateur, Amateur,Solid Paint Bred/Breeding Stock, Novice Youth, Youth 13yr & Under and Youth 14-18yrs. All Classes within the Division to count.

**NorthEast Connection Hi-Pt. and Res Hi-Pt Walk-Trot Champion** will be awarded Trophies. Only Walk – Trot classes to count.

**ALL Hi-Pt and Reserve Hi-Pt Divisions** must have at least (3) Exhibitors competing in each Division. Must show in a minimum of 3 APHA classes in each division, with each class having a minimum of three entries. In case of TIES, Tiebreaker judge will be drawn from the (6) Judges and his card will count twice.

**NorthEast Connection Hi-Pt and Reserve Zone Paint Halter Champions** (regular registry) will be awarded to Stallion, Mare and Gelding. Grand and Reserve Championships to count from (6) Judges. In case of TIES, a Tiebreaker Judge will be drawn from the (6) Judges and his card will count twice.

**1st Horse out of APHA Points** will be given an award in **Selected Classes under one Judge.** Class and Judge will be drawn Saturday and Sunday Morning before the start of show.

### DIRECTIONS TO DREAM PARK:

**From the North:** NJ Turnpike to Exit #2 – Left on to Rt 322 toward the Com Barry Bridge. Before Bridge take Rt 130 South Exit. Follow Below. 295 South toward the Del. Memorial Bridge. Take right fork onto US-130 South toward Bridgeport/Com Barry Bridge. Go 2.1 miles. Continue on 130S Pass under gray lift bridge and look for park entrance 1/4 mile on the right.

### From the South:

Del. Memorial Bridge: Continue on 295 North toward Trenton for 11 miles. Take Exit 10, Center Square Road. Turn left and go approx. 1.5 miles. Turn right on 130 North approx. 1 mile. Look for park entrance on the left at the High Hill Road intersection

### From the West:

Over the Commodore Barry Bridge from PA.Take first Exit (Rt 130 South) on right. Continue approx. 1 mile south. Pass under gray lift bridge and look for park entrance ¼ mile on the right.
